RULES: In consideration for booth space, the Exhibitor/Vendor agrees to the following rules and the signature signifies acceptance of rules as set forth by the authority of the Legion Committee.

- 1. All licenses, fees, permits, etc., must be obtained by the exhibitor/vendor before operation. Responsibility for reporting and paying all fees and taxes to federal, state, and local entities is with exhibitor/vendor. All business will be conducted within the ordinances and laws of federal, state and local entities.*
- 2. The exhibitor/vendor will conduct their business in a quiet and business-like manner, will deposit all refuse, garbage, cans, paper, etc., in proper receptacles and will keep the area of occupancy free from all rubbish and debris. Failure to comply will result in a vendor clean-up fee.*
- 3. The exhibitor/vendor releases the Legion Aux, its' agents or employees from all actions, demands or claims due to damage to person or property or theft.*
- 4. All items for sale have been listed on application to avoid possible rejection.*
- 5. No pets are allowed.*

LOCATION: Bee County Expo Center 351 By Pass, Beeville TX

TIMES: 12:00 noon to 12:00 p.m.

FEES: \$20.00 per booth space. Electricity is included.
Booths are SPACE ONLY. Spaces are 10 X 10... All spaces are assigned by the VFW Committee and are final. Spaces are reserved on a first come, first serve basis. Make all checks payable to American Legion Aux, earmark July 4th Celebration.

ELECTRICITY: Electricity is limited to certain areas. Vendor should bring 25ft. or more of extension cord and duct tape to cover cord.

REFUNDS: No refunds will be made for any reason. No rain dates.

CHECK-IN Prior to set-up. Registration Booth is manned from 9:00 a.m. to 12:00 noon

SET-UP: Vendors may set up as early as 9:00 a.m. Paid spaces must be occupied by 11:00 a.m. or your space will be rented to another vendor. Food Booths must be open until 11:00 p.m. Vendors furnish their own display equipment, tables, chairs, racks, electrical extension cords, etc. Please abide by these rules.

FOOD: Food booths are limited and local service organizations and clubs have priority. Food vendors should contact the Bee County Community Affairs Office 361-362-3232. You must contact the Texas Dept. of Health for guidelines & permits.

OBJECTIONABLE MERCHANDISE IS NOT PERMITTED. Fireworks or explosive charges are not allowed. Objectionable or pornographic material, as judged by the leasing agent is not allowed. No garage sale used clothing is allowed. The July 4th Committee or its representatives reserve the right to ask any vendor to remove merchandise that is not acceptable and refuse merchandise at any time for any reason.

NO ALCOHOLIC BEVERAGES AND NO LIVE AMMUNITION can be brought on the premises by vendors.
